



PAISANO'S 'MAKE AT HOME PIZZA' CONTEST RULES

1. Eligibility: Contest (the "Contest") is open to: (1) those who place an order for 1 or more 'Make at Home Pizza' Kit online via paisanospizza.com, or via the Paisano's app; or, by calling in a phone order for same; and, (2) those who obtain their own pizza making ingredients from a source other than Paisano's restaurants. The contest is void where prohibited by law. The Contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. 'Make at Home Pizza Kits can be delivered to your home or by curbside pickup at the Paisano's restaurant location where you placed your order. The Paisano's Make at Home Pizza Kit includes a fresh dough ball (16") and some flour for 'shaping' your pizza crust; Paisano's Pizza Sauce, Paisano's Cheese and written instructions for preparing and baking your pizza(s); or (2) Obtain your pizza making ingredients from a source other than Paisano's. How to Enter: Upon receipt of your Paisano's 'Make at Home Pizza' Kit(s) or obtaining your pizza making ingredients from another source, take photos of your kit, activities surrounding you and you/your group's pizza creating activities and, of your finished oven baked pizza(s). To enter the Contest, you must post your photos on Facebook, Instagram and/or Twitter. Share the fun (making the pizza) and the finished product (your pizza masterpiece) on social media with #PaisanosMadeByMe. We're looking for good times and creative pies. You can also submit your photos to paisanospizza.com/PaisanosMadeByMe The entry must fulfill all contest requirements, as specified, to be eligible to win a prize.
